**To the Data Protection Officer,**

I am writing to formally protest the deactivation of my Facebook account on **December 9, 2025**. I have been accused of "Sexualisation of Children," a claim I categorically deny as false and defamatory. This decision was made via Automated Decision-Making (ADM) without human oversight or a transparent appeal process.

### **NOTICE TO PRESERVE EVIDENCE**

Under the **Data Privacy Act of 2012 (Republic Act No. 10173)** and in anticipation of a formal complaint to the **National Privacy Commission (NPC)** and potential litigation, you are hereby directed to **immediately cease and desist** from the scheduled deletion of all data associated with the aforementioned account.

**You are required to preserve:**

**All user-generated content, messages, and media files.**

**All logs, metadata, and "logic" used by Meta AI to trigger the deactivation.**

**All internal records regarding the automated review and the subsequent upheld decision.**

### **VIOLATION OF RIGHTS**

Your failure to provide transparency regarding the automated logic used violates my **Right to Information** (Section 16) and **Right to Object** (Section 34) under the Data Privacy Act. Furthermore, the destruction of this data within 180 days constitutes the destruction of evidence related to a criminal accusation made by your platform.

### **Failure of Meaningful Human Intervention**

Furthermore, I draw your attention to **NPC Advisory No. 2024-04 (Guidelines on Artificial Intelligence)**. Under these guidelines, Meta is mandated to implement mechanisms for **meaningful human intervention** in AI-driven processes that significantly affect a data subject's rights. By allowing a "flawed computer program" to uphold its own decision on appeal, Meta has failed to provide the human oversight required under Philippine regulatory standards, effectively denying me due process.

Please confirm receipt of this notice and provide the specific "Oversight Board Reference Number" via email address [geoff.stow@redberry.com](mailto:geoff.stow@redberry.com), and Philpost Registered Mail, as required for me to escalate this matter to the independent Oversight Board.



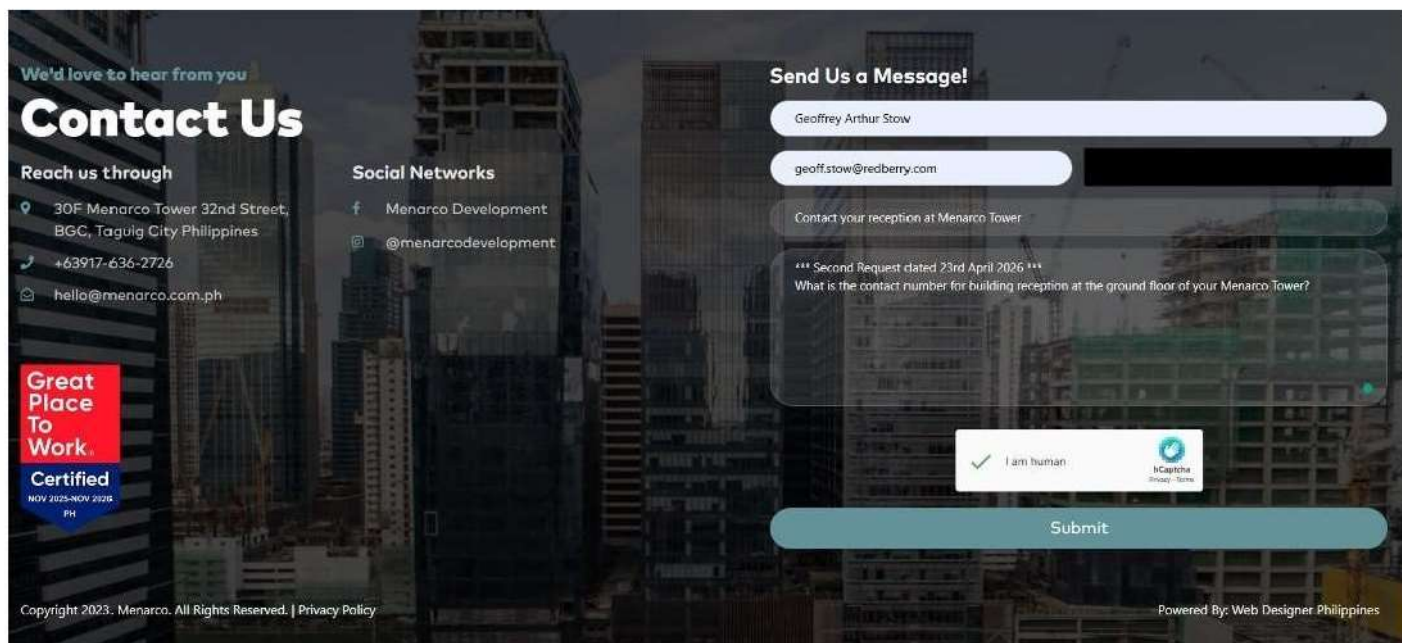

This is the record of my attempts to communicate with Menarco Building Management, who reside in the same building as Meta, but on the 30<sup>th</sup> floor I first tried their web portal which, despite capturing the email address, does not send an automated confirmation response. This is something that I would consider most unusual in my role as a software developer for 50 years, as this infers a company trying to avoid communication. All the data is there, a simple automated response and confirmation of receipt is a menial programming task. It is further worth noting that despite the apparent size of this corporation, the published contact number is a mobile phone, number +639176362726 as may be seen on the image below.



Follows the attempt to communicate to Menarco Building Management via J&T Express, who appear more diligent and transparent as a courier company. The ongoing tracking follows.

I have attempted to serve a formal legal notice to a registered tenant on your 32nd Floor (Meta Platforms) via multiple couriers. On each occasion, building security personnel have refused to accept the documents, citing a "no mail policy."

As the building owners, please clarify:

1. Is it the official policy of Menarco Tower to prohibit the delivery of legal notices to its registered tenants?
2. What is the verified telephone number for your Ground Floor reception to facilitate the coordination of legal service?

Failure to respond to this inquiry, or a further refusal of this letter at your 30th-floor office, will be included as evidence of wilful obstruction in my upcoming filings with the **Securities and Exchange Commission (SEC)** and the **National Privacy Commission (NPC)**.

**AFFIDAVIT**

I, **GEOFFREY ARTHUR STOW**, of legal age, British national, with resident address at [REDACTED] after having been duly sworn to in accordance with law, hereby depose and state that:

1. That on **December 9, 2025**, my Facebook account under the URL [www.facebook.com/geoff.stow.96](https://www.facebook.com/geoff.stow.96), associated with the email address [geoff.stow@redberry.com](mailto:geoff.stow@redberry.com), was deactivated by Meta Platforms International Operations Philippines Inc., with office address at Floor 32, Menarco Tower, 32nd Street, Bonifacio Global City, Taguig, Metro Manila.
2. That the said deactivation was based on an allegation of "*Sexualisation of Children*," which I categorically deny as **false, baseless, and defamatory**.
3. That the decision to deactivate my account was made through Automated Decision-Making (ADM), without meaningful human intervention, and without providing me a transparent and adequate appeal process.
4. That pursuant to the Data Privacy Act of 2012 (Republic Act No. 10173), and in anticipation of filing a formal complaint before the National Privacy Commission (NPC) and possible legal action, I formally demand that Meta Platforms International Operations Philippines Inc. cease and desist from deleting any data associated with my account.
5. That Meta Platforms International Operations Philippines Inc. is hereby required to preserve and retain the following:
  - a. All user-generated content, messages, and media files;
  - b. All logs, metadata, and any algorithmic or system "logic" used by Meta AI in triggering the deactivation;
  - c. All internal records relating to the automated review and the subsequent decision affirming the deactivation.
6. That the failure of Meta Platforms International Operations Philippines Inc. to provide transparency regarding the automated decision-making process constitutes a violation of my:
  - a. Right to Information (Section 16); and
  - b. Right to Object (Section 34) under the Data Privacy Act of 2012.
7. That the deletion or destruction of the aforementioned data within the prescribed period of 180 days will amount to the destruction of material evidence in relation to a serious and defamatory accusation made against me.
8. That under NPC Advisory No. 2024-04 (Guidelines on Artificial Intelligence), entities such as Meta are required to ensure meaningful human intervention in automated decisions that significantly affect a data subject's rights. The failure to provide such intervention in my case constitutes a denial of due process.



9. That I have formally requested confirmation of receipt of my notice, as well as the issuance of the specific Oversight Board Reference Number, to be sent to my email address **geoff.stow@redberry.com** and via PHLPPost Registered Mail, for purposes of escalating this matter to the independent Oversight Board.

10. That I respectfully pray for relief, as follows:

- a. That the Commission issue an Order directing Meta Platforms International Operations Philippines Inc. to immediately suspend the automated deletion of my Facebook account ([www.facebook.com/geoff.stow.96](http://www.facebook.com/geoff.stow.96)) and all associated data, pending the resolution of this case;
- b. That the respondent be ordered to provide a clear and understandable explanation of the logic, data, and parameters used by their automated system (Meta AI) in reaching the decision to deactivate my account;
- c. That the respondent be compelled to conduct a manual, human-led review of the deactivation by a qualified content moderator, in compliance with NPC Advisory No. 2024-04;
- d. Such other reliefs as may be just and equitable under the premises.

11. That I am executing this Affidavit to attest to the truth of the foregoing facts and for whatever legal purposes it may serve.


